SECTION 2: EL26 COURSE REQUIREMENTS & POLICIES

Please read each policy carefully to indicate your understanding and agreement:

Attendance Policy: 80% attendance is required for ELFS, with 100% completion of skills required. Hazardous Materials Awareness (HMA), Traffic Incident Management (TIM), First Aid/BLS CPR, and exam prep are separate from the 80% attendance requirement for ELFS.

Attendance Policy for HMA: Hazardous Material Awareness (HMA) requires 100% attendance per PSFA Policy & Procedures to receive a certificate of completion.

Skills Make-up & Fees: If skills cannot be made up during regular class hours, the student is responsible for scheduling a make-up time, and the following fees will be assessed: \$100 per 4-hour session, plus an additional \$100 per required extra instructor (costs may be split if applicable). If a student misses an excessive amount of skills, they must repeat the program.

Essentials Written Exams: A minimum score of 70% is required to pass. A maximum of three (3) attempts are permitted, with a mandatory 24-hour self-study period required after the first and second failures. The Lead Instructor must verify and sign off on written exam completion before entry to the live fire environment.

Exam Failure Consequences: If a student fails the written exam on the third attempt, they are ineligible to move on to the next level or Live Burn cycle and must retake the class.

Online Program Requirements: To successfully complete ELFS at WCCC-PSTC, you must complete the following online programs and submit a copy to the instructor - ICS-100 and IS-700.

Separate Program Completion: Students that select to not complete the built-in Hazardous Materials Awareness (HMA), Traffic Incident Management (TIM), First Aid/BLS CPR, MUST submit proof of completion from another training agency or online program that meets the PSFA requirements to successfully complete ELFS at WCCC-PSTC.
